## Building, Electrical, Plumbing, and Mechanical Permit Information Sheet

## Building:

A Building Permit is required for construction costing \$500.00 or more. The \$500.00 or more. The Building Permit covers the initial plumbing and electrical permit fees.

A demolition Permit Fee - Liability Insurance is required for demolition.

### Electrical:

An Electrical permit requires that the Electrician MUST comply with the laws of the State of Oklahoma and the Ordinances established by the City of Nowata. If the owner installs the electric, then a waiver must be signed. (Residential only)

## Plumbing:

Plumbers must be licensed by the State of Oklahoma *andthe City of Nowata. Inspections* are required for both rough in and final work prior to hooking up to City utilities.

#### **HVAC:**

Contractors must be licensed by the State of Oklahoma and the City of Nowata.

#### Tie-Down:

All tie downs shall meet all minimum Federal, State and City safety regulations and <u>must be</u> <u>Inspected and approved before skirting is applied.</u>

#### **Grease Traps:**

All grease traps must be installed according to the IPC. Traps installed under sinks must be designed for the flow rate of the water entering City pipes from the sink. If the City must rod sewer lines and find grease from that business, they will be issued a warning for violation of City Codes. The second time, the business will be fined and DEQ will be contacted.

## MANUFACTURED HOMES PLUMBING, ELECTRICAL AND HVAC PERMITS AND REQUIREMENTS

#### **REQUIRED:**

- Inspection on sewer line and connections before covering.
- Inspection on water line before covering.
- Inspection on electric hook up.
- Inspection on tie downs.
- Inspection on gas lines as required.

Permits can only be issued to licensed State and City registered tradesman for each trade.

\*Exception: Homeowner can receive a permit only if they are doing the work themselves. All work must meet code requirements and must be inspected.

Homeowners doing their own work must familiarize themselves with those requirements and sign a waiver with the City of Nowata.

SEWER PIPE AND WATER LINE MUST BE SCHEDULE 40 OR BETTER. MUST BE INSPECTED PRIOR TO COVERING.

WATER LINE MUST BE AT LEAST 18 " DEEP AND HAVE AN ACCESSIBLE WHOLE HOUSE SHUTOFF VALVE.

SEWER LINE MUST HAVE AN EXPOSED AND READILY ACCESSIBLE TWO-WAY CLEANOUT.

- 2 Site plan, foundation, elevation, and typical section plan, showing all wiring, plumbing, air conditioning, and construction details and dimensions are required. The granting of this permit does not grant any right of privilege to: erect any building, structure, or any portion thereof, upon any street, alley, or public place or portion thereof, or use any structure or portion that is or may be prohibited by ordinance of the City of Nowata.
- 3 I (We), hereby certify that no part of this work had been started, and I(We), assume full responsibility for compliance with all city building, plumbing, electric, sanitary, and construction requirements. It is understood and agreed by this applicant that any error, misstatement or misrepresentation of material fact, of expression of material fact, either with or without intention on the part of the applicant, such as might, or would, operate to cause a refusal of this application, of any material alteration or change in the accompanying plans, specifications, or structure made subsequent to the issuance of a permit in accordance with this application, without the approval of the City of Nowata, shall constitute sufficient grounds for the revocation of such permit.
- 4 I hereby affirm that I have read the above. I am familiar with all applicable codes and standards and will comply with all provisions as set forth by the City of Nowata.

**Submit Application**- The permit application requires information about your construction permit, the address of construction must be provided, unless it is a new structure, along with the legal description for the property, the owners name, the contractors name, the architects name if applicable. The square footage of the new structure, including porches, patios, and garages must also be provided. Please submit two sets of plans (one digital and one physical), including a site plan, and any other documentation of the proposed work for review. To obtain an application Please visit the Nowata City Hall Located at 114 South Maple Nowata or down load a copy from the city website.

**Review Process**- During this process your application may be routed to different departments for their approvals. The normal review time for residental projects is two to five business days. For commercial projects the normal review time is five to ten business days. Permits for roofs, siding and fence replacement can be issued at the time of application.

**Issuing Permit-** Once the permit has been approved by all necessary departments the permit is ready to be issued. The building permit is a document granting you legal permission to start your project, Upon approval of a building permit a permit fee will be collected. The permit fee is issued to defray the cost of the application process, and review and inspection site. Changes will require a review and approval by building official.

All rough-ins must be inspected and approved before framing inspection is called in. Rough work in ceilings, walls, and floors shall not be covered until the inspection has been approved.

All finals must be inspected and approved before the building final is requested.

The Certificate of Occupancy for **businesses** can be requested **after** the building final has been approved. All fixtures, furniture and accessories must be in place and ready to open for business when this inspection is requested.

The Certificate of Occupancy of **residential** can be requested after the final has been approved. You must have your house numbers displayed at the time this inspection is requested.
